# according to the Regulation of the European Parliament and the EU Council 2016/679

- if you purchased the goods from us, you can be like our subscribers chosen to fill in our customer satisfaction questionnaire (if you are not interested in fill in the questionnaire, please respond to this email)

- if you are our customer you can be informed about our offer and new products without your previous permission (if you are not interested in send to inform about news, please respond to this email)

- persons who provide services for Manager for the proper performance of the contract, fulfilling the obligations established in the generally binding legal regulations and to protect its interests (auditors etc.).
